# Independent Study Credit Overview

Independent Study provides an opportunity for original study or investigation in the major or field of specialization on an individual and more autonomous basis. Independent Study may not be used as a substitute for a catalog course nor as a means of taking a catalog course on an individualized basis. Requires application well in advance of regular registration, and must be approved by both the instructor with whom the student will work and the School of Sustainability.
